ORDER

I&L/CEE/902/65/3390

In exercise of the powers conferred under Rule 133 of the Indian Electricity Rules, 1956, the Government of Goa, Daman and Diu, relaxes the provisions of the Indian Electricity Rules, 1956, to the extent mentioned below in so far as rural electrification lines are concerned with immediate effect:—

Rule 35(b): Caution Notices.— Caution Notices on overhead lines of 37.5 KV. and below shall be limited to the following:—

- (i) All supports inside a village or panchayat;
- (ii) Up to 5 supports in every direction outside the boundary line demarcated for any village or panchayat;
- (iii) Supports at all road crossings.

Rule 54: Declared voltage of supply to consumers.— The voltage variation limit in the case of low or medium voltage lines shall be increased from 5 per cent to 8 per cent in rural areas.

Rule 68(b): General conditions as to transformation and control of energy.— The height of 8 feet specified in this rule for fencing shall be reduced to 6 feet in the case of rural out-door sub-stations and switch stations.

Rule 76(c): Maximum stresses: Factors of safety.— The following factors of safety on crippling load shall be adopted in the design of rural lines:—

- i) For metal supports 1.5
- ii) For wood supports 3

Rule 77: Clearance above ground of the lowest conductor.— For low and medium voltage overhead lines along any street, the minimum clearance above ground shall be 15 feet except for locations where such lower clearance would become dangerous to vehicular traffic or parked vehicles.

Rule 81: Conductors on different voltages on the same supports.— A supplier shall have the option to dispense with guarding between high-voltage and low-voltage lines on the same supports along the street in rural areas unless demanded by the Electrical Inspector in any specific locality.

Rule 91(3): Safety and protective devices.— In the case of overhead lines of 37.5 KV and below, the supplier shall have the option to dispense with anti-climbing devices on the supports of such lines in rural areas except in the following locations:—

- (i) All supports inside a village or panchayat;
- (ii) Up to 5 supports in every direction outside the boundary line demarcated for any village or panchayat;
- (iii) Supports at all road crossings.

These relaxations shall not apply to any lines where they are running through or within half a mile of cities or towns with a population of 10,000 or above.
